- 1. BY-LAWS: Dave was authorized in Glenn's absence to give the second reading and conduct the vote on the two (2) by-laws.submitted by Steve Biaggi:
- 1. Section 2. Article 1-Business: Vote to Accept the Agenda This is covered by Robert's Rules but may clarify for future boards A hand vote was taken and the by-law PASSED.
 - 2. Section 2, Article IV-Election of Officials

The election of Association Officials shall take place at the same time and at the place of the Annual Meeting, as set forth in Article IX of the By-laws.

Change:

"The Nominating Committee shall have the slate of candidates posted in all FSA Districts (where state tournaments are held) not later than 2 weeks prior to election day. Should any position be vacant it shall be shown as Candidate Needed."

Discussed that this by-law has merit but needs tweaking. It may be discussed at a future meeting. It was noted that amendments cannot be made to ten day notices.

A hand vote was taken and the by-law FAILED.

2. Tournament Schedule (2020/2021)

Motion made by Bob Hovatter, seconded by John Brown to accept the proposed Open Schedule. Several changes were discussed, such as starting the redline singles (hall of fame) tournament at 8:30 A.M. instead of 9:00 and changing it to a doubles tournament. This would require a rule change. Splitting the two nationals was discussed and Bob Hovatter stated that these tournaments bring no money to the state and the national president had no objection. Vote was taken, passed, and schedule will be posted on the FSA website. Motion made by Bob Hovatter, seconded by Phil Rebholz to accept the Amateur schedule and passed. This too will be posted on the FSA website.
